- Provide complex and responsible support to the Director and Deputy Director in areas of expertise.

- Has knowledge developing and implementing recreation, social services, and/or education programs.
- Has the ability to provide administrative, management, and professional leadership support for their assigned division.
- Is excited by challenges, loves to learn, and thrives in a collaborative, fast-paced environment.

## Qualifications

Any combination of training and experience that would provide the required knowledge, skills, and abilities is qualifying. A typical way to obtain the required qualifications would be:

- **Education:** Equivalent to a bachelor's degree from an accredited college or university with major coursework in parks and recreation administration, public administration, human services, sociology, or a related field.
- Experience: Five (5) years of responsible community services programming administration experience, including three (3) years of experience in a supervisory or management capacity. Five (5) years of experience as a Supervisor, Manager, and/or Superintendent in Community Services, Parks & Recreation, or a closely related field, is preferred.
- Licenses and Certifications: Possession of a valid California Driver's License, to be maintained throughout employment.

## **Special Requirements**

### **Physical Demands and Working Conditions:**

- Mobility to work in a standard office setting and use standing office equipment, including a computer.
- Operate a motor vehicle and visit various community sites.
- Vision to read printed materials and a computer screen.
- Hearing and speech to communicate in person and over the telephone.
- The ability to lift, carry, push, and pull materials and objects averaging a weight of 25 pounds, or heavier weights, in all cases with the use of proper equipment and/or assistance from other staff.
